- 2. PER CITY ORDINANCE, NO ALCOHOLIC BEVERAGES MAY BE CONSUMED OR DISPLAYED ON PUBLIC PROPERTY WHICH INCLUDES THE STREET OR SIDEWALKS.
- 3. ANY BLOCKING OF THE STREET WILL BE LIMITED TO ONE SIDE OF THE STREET IN ORDER THAT EMERGENCY VEHICLES (FIRE, EMS, POLICE, ETC.) CAN EASILY ACCESS THE STREET.
- 4. APPLICANT SHALL MONITOR THE STREET BARRICADES IN ORDER TO ENSURE THEY ARE CONTINUALLY IN THEIR PROPER PLACE TO EFFECTIVELY RESTRICT TRAFFIC.
